6. DIRECTOR'S REPORT:

- a. Fire Standpipe We are having a few problems with the completion of this project. The new fire pump has been installed but there are some new codes which the electrical inspector stated we need to have installed. Steve Curry has said that the water pressure in this building is high enough that it is not necessary for us to have a fire watch on the building while work is continuing. It is in operating condition every night after work is done. J.T. Safety Co., Uly and I are having a meeting tomorrow morning to discuss the situation. We may need to upgrade our electrical in the fire pump room.
- b. The staff is working very hard on transferring files and ultimately our goal is to dispose of files per Regulations,
- c. I had heard we were having a State Inspection per DCA after hearing this I walked around the building and discover that some sidewalk repairs needed to be done. There was a neighbor's tree which was causing our sidewalks to lift. I spoke to the neighbor they agreed to have the tree removed so the sidewalk could be repaired. The tree was removed and we were able to have the sidewalks in the back repaired to ease safety concerns regarding a tripping hazard
- d. We were approved by the County of Bergen for \$ 61,000.00 in grant funds for the waterproofing/caulking of windows and a/c sleeves at the Harry J. Holtje House. John Donovan is preparing Specs. for an A/E and we hope to have them by our next meeting. We may need a Special Meeting in November to approve this Resolution.

- e. HOTMA which stands for Housing Opportunities through Modernization, has been delayed again due to HUD's delay in issuing Regulations and Interpretations which are suppose to streamline the process, eliminate waste which will result in people being terminated. Example, new tenants coming on the program cannot have over \$ 100,000.00 in savings which in this economy is not enough. If they are terminated and have to pay full rent (especially in the Fort Lee area) they will use up that amount in no time.
- f. **Personnel Policy.** We utilize the JIF MEL policy for both our Personnel policy and employee handbook. Every two (2) years The JIF updates their policy mostly for purposes related to liability and requires that we update our policy accordingly. We have made the adjustments that were required and need Board approval for same.
- g. We just received a commitment from the County of Bergen for Unprogrammed Funds in the amount of \$ 14,000.00 for automatic doors for 1405 for a handicapped resident who is having difficulty opening and closing these entry doors.

HOUSING AUTHORITY OF THE BOROUGH OF FORT LEE MINUTES OF REGULAR MEETING ON OCTOBER 4, 2023

Thomas Furlong, our Accountant, prepared a Budget Worksheet showing figures for 2022, 2023 and 2024 for review by the Commissioners. He explained each item and reported on some of the changes, namely our dwelling rents are going up as the tenants are earning more which in turn raises their rent and we expect that to continue. They are estimated to be approx. \$ 210,000.00 for 2024. Administrative salaries are expected to go up as salaries increase. We increase salaries across the board. Our HAP payments (rent subsidies) are increasing as we are filling our voucher spots, bring our numbers up. As always, health increase a bit. This cost has increased considerably but as we are a member of the JIF and our policies include everything ie. property, worker's comp, liability, cybersecurity etc. a 10% increase in cost is very reasonable. We have a good reserve for the size agency we are so the Board should be very pleased with that. Our Budget is expected to be approved by the State and should be adopted at our Meeting of December 6th, 2023. The Fort Lee Housing Authority is in very good shape.
